\*Contributions to RPAC are voluntary, not mandatory and are used for political purposes. The minimum contribution recommended is \$25.00; however you may give more or less or refuse to contribute without reprisal. 70% of each RPAC contribution is used by Georgia RPAC to support state and local political candidates and issues. The remaining 30% is sent to National RPAC to support federal candidates. A \$99.00 contribution to RPAC qualifies you for the elite "99" Club; a \$200 contribution qualifies you for the Capital Club and a \$1,000.00 contribution qualifies you for the Sterling R.

**Certain provisions of the Tax Act regarding lobbying expenses limit the extent to which the National, State and Local dues will be deductible. The portion of dues paid that is spent to lobby the State and Federal governments is not deductible for income tax purposes. GAR has estimated that \$17.13 (23.47%) is the nondeductible portion of 2010 GAR dues. NAR has estimated the nondeductible portion of its 2010 dues to be \$26.00 (32%). The entire \$35.00 NAR Public Awareness Campaign Assessment qualifies as deductible dues. TOTAL DUES ARE "NOT DEDUCTIBLE FOR INCOME TAXES"**
